*Celebrate With Music* is the major fundraiser for scholarship money for NFMTA. This performance opportunity at the Mall should not be considered a formal recital situation, as there will be significant background noise. Please take this into consideration before you decide to have your students participate. We cannot ask shoppers in the mall to **be quiet**; nor can we expect the Mall to silence their Christmas music for us. However, even with these inconveniences, there are real benefits.

- You can bill this as your mid-year recital, taking some pressure off during this busy season.
- Your students can learn to shut off the distractions and focus on the music.
- Those students who struggle with performance anxiety in formal settings may feel more relaxed.

**TO RESERVE A TIME SLOT:** A non-refundable deposit of \$40 is required to reserve a block of time and can be mailed to Myrna, or handed to either Myrna or Mimi at a meeting, with the completed Time Request Form. Requests for specific times will be considered in the order they are received, and your time block will be confirmed to you via e-mail.

**REGISTRATION:** Use the **Sign-Up Form in the Member Handbook**. Teachers may submit check and paperwork by mail to Myrna Feigenbaum, or give them to Myrna or Mimi at the September, October or November meetings only. The registration **deadline is November 8, 2011**. After this date any teacher whose registration is incomplete (**items 1 or 2 below are missing**) will forfeit his/her time slot. The Repertoire list is due by **January 10, 2012**. **Teachers who fail to submit their Repertoire List will be ineligible to participate in the Celebrate with Music festival in 2012!**

1. **Check (total number of students x \$9)—No Cash!**
2. **Sign-Up Form and Performer List**
3. **Repertoire list (due by Jan. 10, 2012.)**

**PERFORMANCE TIME ALLOWED:** Each studio may request up to 2 hours, in 30-minute increments. Remember that we have many students wanting to perform. Please plan your time carefully. **We will try** to honor all requests over 1 hour and will try not to split such a request between the two mall locations, but this cannot be guaranteed.

**MUSIC:** Most students play “holiday” music, but that is not a requirement. In previous years students have enjoyed playing solos, duets, and quartets. Such small ensembles can provide additional performance opportunities for students within the assigned time block. And please remember; your Repertoire Lists are needed so that MTNA can pay all royalties due to the composers.
